#### **Procurement**

In addition to the services we are commissioned for, Dakota strives to provide a streamlined, consistent and standardised approach to the procurement of goods and services.

The economic, social and environmental considerations form a significant part of the selection criteria that Dakota uses when choosing suppliers (see our <a href="Ethical Trading Policy Statement">Ethical Trading Policy Statement</a>).

As such, we aim to undertake a responsible approach to the evaluation and selection criteria of all goods purchased by, and services provided to, Dakota. This approach to ethical procurement principles is applied to 100% of contracts, and also includes the following criteria:

- Assessing all external procurement and supply chains for modern slavery risks
- Considering whether our suppliers pay their taxes, pay the national living wage, promote Corporate Social Responsibility and have robust sustainability policies
- Seeking local providers and suppliers as a preference
